DISCIPLINARY ACTIONS

Case #2020-021BR

Respondent: Lihua Stahl, owner of A+ Massage

April 10, 2020

Allegation: Lihua Stahl, owner of A+ Massage, violated Ala. Code §§ 34-43-11(a), 34-43-11(b) and 34-43-15(d)(1), as well as Ala. Admin. Code r. 532-X-5-.03(1)(c), 532-X-5-.03(1)(h), 532-X-3-.04(5)(a) and 532-X-5-.02(1) for operating an unlicensed massage therapy establishment, employing unlicensed massage therapists, failing to carry the required insurance coverage for an establishment and advertising an unlicensed massage therapy establishment without an establishment number.

Board Action: Lihua Stahl entered into a Consent Agreement with the Board regarding the alleged violations. Pursuant to the Consent Agreement, Lihua Stahl was assessed a fine in the amount of \$2,000.00 and placed on probation for a period of one (1) year.

Respondent: Min Yang Wang, owner of M & Y Chinese Therapeutic Massage

April 10, 2020

Allegation: Min Yang Wang, owner of M & Y Chinese Therapeutic Massage, violated Ala. Code §§34-43-11(a) and 34-43-11(b), as well as Ala. Admin. Code r. 532-X-5-.03(1)(c) and 532-X-5-.03(1)(h) for operating an unlicensed massage therapy establishment and employing unlicensed massage therapists.

Board Action: Min Yang Wang entered into a Consent Agreement with the Board regarding the alleged violations. Pursuant to the Consent Agreement, Min Yang Wang was assessed a fine in the amount of \$1,000.00 and placed on probation for a period of one (1) year.

Respondent: James Wolfe, owner of One Therapy

January 10, 2020

Allegation: James Wolfe, owner of One Therapy, violated Ala. Code § 34-43-15(b)(10) for allowing the massage therapy establishment to be used as an overnight sleeping accommodation.

Board Action: James Wolfe entered into a Consent Agreement with the Board regarding the alleged violations. Pursuant to the Consent Agreement, James Wolfe was assessed a fine in the amount of \$500.00 and placed on probation for a period of one (1) year.

Respondent: Bing Ji owner of Mei Massage; Shaofei Chen, manager of Mei Massage

January 10, 2020

Allegation: Bing Ji, owner of Mei Massage, violated Ala. Code §§ 34-43-8(a), 34-43-11(a) and 34-43-15(b)(5), as well as Ala. Admin. Code r. 532-X-5-.03(1)(c) for employing unlicensed massage therapists and operating a sexually oriented business.

Board Action: Bing Ji surrendered the establishment license for Mei Massage.
